Decision of the President of the Cassation Court

No. (12/2020)

- Having reviewed Articles 4 and 9 of Law No. 23 of 1990 concerning the Organization of the Judiciary.
- And upon the decisions of the Council of Ministers regarding the suspension of work in government agencies from 12/03/2020 and its extension until 29/06/2020.
- And upon the decisions of the President of the Court Nos. 6, 7, and 10/2020 concerning the continuation of work in the deliberation chamber and its continuation during the summer recess with the same work distribution of the General Assembly held on 30/09/2019.
- And upon the decisions of the General Assembly of the Cassation Court held on 30/09/2019 regarding the distribution of work during the judicial year and authorizing the President of the Court in some of his competencies.
- And in consideration of the public interest.

IT IS DECIDED

Article (1): Work in the court's circuits shall resume starting from 30/06/2020, with the same distribution as stated in the decision of the court's General Assembly held on 30/09/2019, and the decisions of the President of the Court issued in this regard, including the issuance of judgments and decisions of the deliberation chamber, taking into account the provisions of the President of the Court's decision No. 9/2020 regarding the rules for completing the formation of circuits in case of a shortfall.

Article (2): For the appeals that were reserved for judgment during the work suspension period since 12/03/2020, another session shall be scheduled for the pronouncement of the judgment, and the litigants shall be notified of this session.

Article (3): Each circuit shall list all appeals pending in hearing sessions that have been administratively postponed, and inform the Court Clerk's Office to take the necessary action to notify the litigants of the newly scheduled sessions.

CASSATION COURT Office of President

Article (4): In observance of Article 17 bis of Law No. 5 of 2020 amending some provisions of Decree-Law No. 38 of 1980 issuing the Civil and Commercial Procedure Law, the Court Clerk's Office shall continue to receive, register, and serve appeal petitions for judgments issued before 12/03/2020.

Article (5): The presiding counselors of the court's circuits are entrusted with determining the number of appeals to be heard in deliberation and hearing sessions, as well as the number of people present in the courtroom, in compliance with preventive health requirements.

Article (6): This decision shall be effective from 30/06/2020.

Article (7): The attorneys, court counselors, and the Ministry of Justice shall be notified of a copy of this decision.
